II. APPROVAL OF MINUTES

V. COMPLIANCE REPORT

A. This month has been a whirlwind of trying to keep up with new mandates and regulations as they are passed down from the governor and CDPHE. There has been policy change on what seems like a daily basis and updates to procedures as there is more data and practices around COVID-19. All of this has been done through our ransomware attack and on our personal emails using our phones as hotspots. I believe we have managed to keep up with required reporting (EMResource through the ED and SHIP grant activities through HIM) without missing a deadline, as well as combing through emails forwarded from contacts with the WHA and CRHC to make sure we are able to apply to grants on time and gny other pertinent information that has come out. Toni Foos with Telligen has been incredibly helpful with keeping us in the loop on the Infection Control information, since our IP nurse is in the middle of a pandemic for the county. All CMS and MBQIP reporting Is optional for this reporting period. And any reporting done will not reflect actual hospital performance due to COVID. We are currently working on getting our Prevention and Response Plans (RDH and Eagle Crest) submitted to the State by May 1st in order to be in compliance with the amended Public Health Order 20-20. We had all necessary strategies in place and have been working on building accompanying policies and attaching as documentation. Last wee we had a surprise visit from CDPHE for a focused Infection Prevention survey and had our exit interview yesterday. We had a deficiency free survey and the survey is now closed. Right now, we are preparing for a "new normal" as the county begins to open up, and will adjust our processes as we learn.

VI. FINANCIAL REPORT

A. Financial Notes for April 30, 2020

On April 8, 2020, Rangely Hospital District suffered a major cyberattack. As of today, we are just starting to recover some of the files from which the financials are normally built. Although we have insurance, which is covering the expense of recovery for the computer systems, the actual recovery process for operations will likely be difficult and painful process for many areas of the hospital. Since we do not currently have the capability to produce a valid set of financials, we have listed some important financially-related events below.

- As of 03/31/2020, our unrestricted cash balance is \$8,496,293.09.
- We have received about \$395,000 from CMS in Covid-19 funds for our SNF beds.
- We have applied for, and received, about \$1.6 million from the Paycheck Protection Program. Though the SBA usually only loans to private entities by law, due to the pandemic, Congress has authorized loans to non-private hospitals for this package. Most of this loan will not have to be repaid.
- We have received about \$70,000 from SHIP grant for COVID-19 response.
- Various other grants are being plied for by operating departments.
- We will continue to watch for new stimulus monies for which our hospital can apply as we go forward.

We expect to be able to produce a full set of financials, as per our normal process, by the end of May.
