This matter coming on to be heard upon petition of electors, by their attorney, R. J. O'Callaghan, for the organization of the Rangely Hospital District, and the Court having heard the Petition, there being no objections filed thereto, and now being sufficiently advised in the premises,

BOTH FIND:

1. That the number of registered voters in the proposed district is 1256 as of the date of the petition.
2. That the petition filed herein has, within ninety (90) days preceding the filing of the petition, been signed by duly qualified electors totaling not less than fifty percent (50%) of all the registered voters residing within the proposed district as of the date of the petition.
3. That the petition filed herein is in substantial conformity with the law.
4. That due notice of the filing of said petition and the date set for hearing objections to the organization of the district has been published for three consecutive weekly publications in the "Rangely Times", a newspaper of general circulation in the County of Rio Blanco, not less than sixty (60) nor more than ninety (90) days prior to the date set for hearing objections thereto.
5. That the Court has jurisdiction hereof.

IT IS ORDERED, ADJUDGED, AND DECREED:

That Rangely Hospital District be, and the same is hereby ordered and declared, duly organized under the laws of the State of Colorado; that said District shall have and exercise through its proper officers all of the power and authority conferred upon hospital districts under and by virtue of the provisions of Chapter 179, 1959 Session Laws, and all such power and authority as may hereafter be conferred by law; that said District be, and

the same is hereby declared, created and established as a governmental subdivision of the State of Colorado, and as a body corporate, with all powers of an instrumentality or political subdivision of the State of Colorado;

That the boundaries of said District and the territory to be included therein is as follows:

Beginning at the intersection of the range line between Ranges 97 and 98 West of the 6th P.M. and the North Boundary of Rio Blanco County; running thence South along said range line to the Southeast Corner of Sec. 1, T2N, R98W; thence West to the Southwest Corner of said Sec. 1; thence South to the Southeast Corner of Sec. 14, T2N, R98W; thence West to the Southwest Corner of Sec. 18, T2N, R98W; thence South along the range line between Ranges 98 and 99 West to the Base Line; thence West along the Base Line to the Northeast Corner of T1S, R99W; thence South along the range line between Ranges 98 and 99 West to the Rio Blanco-Garfield boundary; thence West along said boundary to the Northeast Corner of Sec. 24, T4S, R100W; thence South along said boundary to the Southeast Corner of Sec. 36, T4S, R103W; thence along said boundary to the Colorado-Utah State Line; thence North along said State Line to the Rio Blanco-Moffat County Boundary; thence along said boundary to the point of beginning.

That the following persons are hereby appointed as the first board of directors of said District to serve the term indicated:

and, after qualifying for office, shall be vested with all the powers, duties and obligations of directors of said District as conferred by said laws, and as may by law be hereafter provided.

That the Clerk of this Court shall transmit to the County Clerk and Recorder of Rio Blanco County, Colorado, a certified copy of this order for filing and preserving as provided by law.
